On September 11, 2014, the Nebraska Public Power District ("OPPD") filed a Petition for Intervention in the above-captioned proceeding. Pursuant to Neb. Rev. Stat. § 84-912.02, the hearing officer is to issue an order granting or denying each pending Petition for Intervention prior to the hearing, and briefly state the reasons for the order.

In support of its Motion, NPPD states that it is an electric power supplier with certified service areas in the State of Nebraska, and is a party that was identified in the Power Review Board's Notice of Filing and Hearing Date as an interested party in this proceeding.

I note that in paragraph 5 of the application, Applicant lists NPPD as one of the "owners of electric generation facilities, electric transmission lines, and/or related facilities, and any other persons or organizations known to the applicant whom the applicant believes to be interested in this application." In its written Notice of Filing and Hearing Date the Power Review Board identified NPPD as an entity that it deems to be an interested party to application PRB-3777-G.

I find that the Petition for Intervention was submitted in writing, with copies mailed to all parties named in the notice of hearing; that the Board has already acknowledged that NPPD is an interested party affected by this application; and that NPPD's intervention serves the interests of justice and will not impair the orderly and prompt conduct of the proceedings.

Based on the foregoing, the Nebraska Public Power District's Petition for Intervention is hereby granted. There are no conditions or limitations placed upon NPPD's participation in the proceedings.
