The City of Kimball, Nebraska applies to the Nebraska Power Review Board for an order authorizing it to construct or acquire electric generation facilities and/or related facilities in Kimball County, Nebraska, as hereinafter set forth below:

Farris Engineering has been hired by the City of Kimball's contractor NMC CAT, project manager Greg Donahoe, NMC, 11002 Sapp Brothers Drive, Omaha NE 68138.

The interconnection of the new generation facility will require cabling and 1200 amp bus-tie circuit breaker section with the appropriate bus differential protection for the existing 15kV switchgear which is located in the existing substation building located immediately adjacent to the new generation facility which is located on the same property and adjacent to the old generation facility.

(5) The owners of electric generation facilities, electric transmission lines, and/or related facilities, and any other persons or organizations known to the applicant whom the applicant believes to be interested in this application are:



Western Area Power Administration (WAPA) have been contacted regarding this facility as the existing substation is powered from their 115 kV bus located South of Kimball. Due to this being a replacement for the existing outdated generation, they did not require the City of Kimball to go through any study process. We have remained in contact with WAPA to ensure that we are installing acceptable material to meet their metering requirements.

(6) Waivers and consents from the following are attached: We are in constant contact with WAPA to maintain compliance with their requirements.

(7) The proposed electric generation facilities and/or related facilities will serve the public convenience and necessity, and the applicant can most economically and feasibly supply the electric service resulting from the proposed constructing or acquisition without unnecessary conflict and duplication.

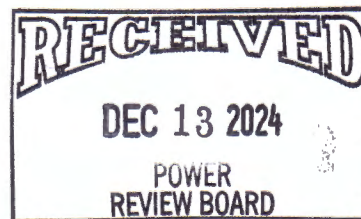

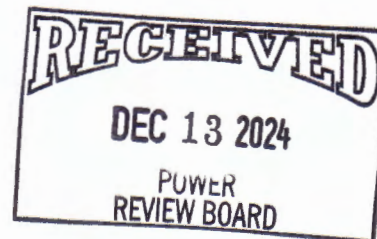
