(3) Purpose of construction and description of related facilities: <u>City of Central City is</u> rebuilding it's transmission line from the NPPD Central City 115 substation along HWY 14 to the north. This will convert the voltage from 34.5kV to 69kV. This Central City's transmission and Southern's distribution underbuilt line crosses through the Southern Public Power District Service Area to get back to their own service territory.

(4) Name, address, and type of customers to be served:

The new transmission line will continue to serve their customers. The entire City of Central City will be served off of this new line in the Southern Public Power District territory. In this particular case, Southern Public Power District will own the underbuilt distribution in this section to serve their customers.


