COME NOW Cornhusker Public Power District, a public corporation and political subdivision organized and existing by virtue of the laws of the State of Nebraska ("Cornhusker") and Loup River Public Power District, a public corporation and political subdivision organized and existing by virtue of the laws of the State of Nebraska ("Loup District") and jointly apply to the Nebraska Power Review Board ("the Board") for an Order Amending Service Area Agreement 252 ("SAA-252").

In support hereof, the Applicants state as follows:

- 1. That Loup District is the supplier of electrical service to the Village of Lindsay, Platte County, Nebraska and Comhusker supplies the electrical service to customers outside of and adjacent to the Village of Lindsay's city limits. That attached hereto as Exhibit "A" is a Plat showing the current service area of Loup District for the service of the Village of Lindsay. That in December of 2023 the Village of Lindsay annexed additional property into the city limits of the Village of Lindsay and attached hereto as Exhibit "B" is a copy of the Annexation Plat with the newly annexed property being shown in yellow. That a portion of the City Limits as shown in Exhibit "B" is not in Loup District's current service area and now, as part of the City Limits of the Village of Lindsay, should be in Loup District's Service area. There are no electrical users in the area to be transferred from Cornhusker to the Loup District and no electrical facilities to be transferred. That Exhibit "C" attached hereto is a revised service area map showing the said east area as part of Loup District's service area. That SAA-252 should be amended to show the service area boundary as shown on Exhibit "C".
- 2. No other supplier of electricity in Nebraska has an interest in this transaction.

3. The proposed amendment to SAA-252 is in the public interest and in accordance with the policies of the State of Nebraska set forth in Chapter 70, Article 10 of the Revised Statues of the State of Nebraska.

WHEREFORE, the Comhusker and the Loup District jointly request that the Nebraska Power Review Board enter an appropriate Order amending SAA-252.


