This Amendment, made and executed June 10, 2024, by and between the City of Valentine, Nebraska, (“Valentine”) a municipal corporation of the State of Nebraska, and the K.B.R. Rural Public Power District (“KBR RPPD”) a public corporation and political subdivision of the State of Nebraska.

WHEREAS, the Parties did pursuant to such statutes enter into a retail Service Area Agreement designated as SAA 405 which was approved by the Nebraska Power Review Board, and

WHEREAS, Amendments to the above referenced Service Area Agreement have been approved by the Nebraska Power Review Board from time to time; and

WHEREAS, the Parties have reached an agreement defining their respective retail service areas and, as a result, the Parties desire to modify their existing Service Area Agreement to reflect this situation.

NOW, THEREFORE, pursuant to said statutes, the Parties jointly apply to the Nebraska Power Review Board for purpose of modifying the service area boundaries in the subject service area agreement under the terms of the following mutual provisions.

FIRST

Attached hereto, marked Exhibit A, and made apart hereof by reference as though set forth in detail herein, is a map that shows a portion of the existing retail service area for Valentine adjacent to the service area of KBR RPPD, the existing boundary between the two and also clearly identifies the proposed amended service area boundary between Valentine and KBR RPPD.

The parties hereto propose that the existing retail Service Area Agreement 405 between the Parties be amended as set forth on Exhibit A and described in Exhibit A.

SECOND

This amendment to the retail Service Area Agreement 405 shall become effective only after approval by the Nebraska Power Review Board and shall thereafter become a part of the retail Service Area Agreement 405, which was approved by the Nebraska Power Review Board.

THIRD

This amendment to the retail Service Area Agreement 405 is executed by the Parties to assign or modify only the retail service areas set forth in retail Service Area Agreement 405. All other provisions of retail Service Area Agreement 405 shall remain in full force and in effect.

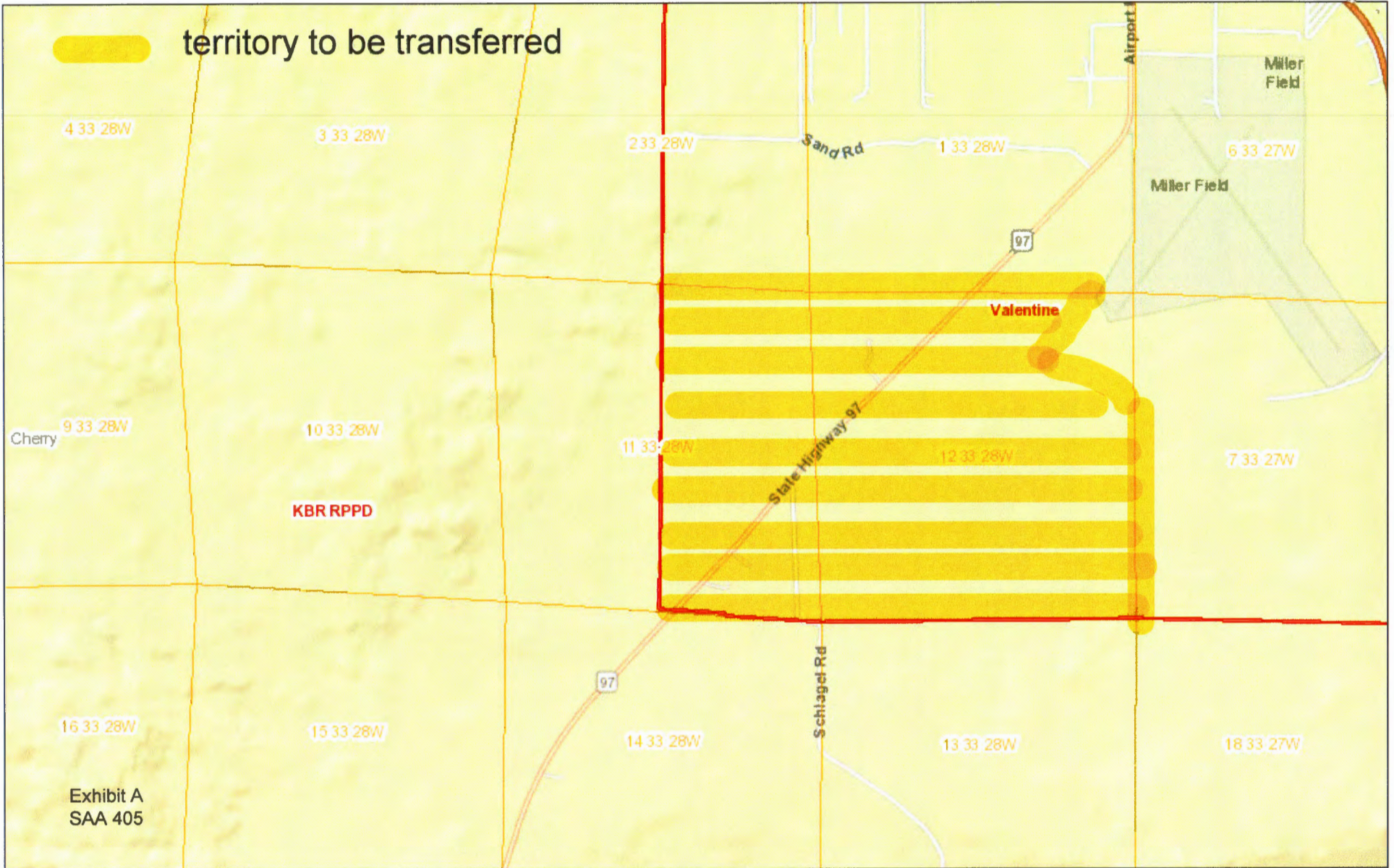
